Terms and Conditions of the Leapfrog Childcare Voucher Scheme ('the Scheme'):

1. You acknowledge that it is your responsibility to pay all applicable Tax and / or National Insurance on payments made by you to the Childcare Provider in accordance with the Law.
2. We make no representation or warranty as to the amount of National Insurance Contributions (NIC's), which you may save by participating in the Scheme. We recommend that you seek independent advice regarding your NIC position.
3. You acknowledge that it is your responsibility to select the Childcare Provider.
4. You acknowledge that we are in the business of providing the Scheme only. Accordingly, unless you choose to place your child/children at a Leapfrog Day Nursery (in which case the Leapfrog Day Nurseries standard Terms and Conditions shall apply) you acknowledge and agree that save as set out in the Unfair Contract Terms Act 1977 and save in the case of fraud, we shall have no liability to you for any claim whether arising in contract, tort (including negligence) or otherwise, whatsoever.
5. You agree that the Childcare Vouchers, once issued, are non-refundable and may only be used by you in making payment to a Childcare Provider, which is legally entitled to provide childcare to your child/children.
6. We reserve the right to vary the operation of the Scheme or terminate the Scheme without liability to you:
 - a. Immediately on giving notice to you, in the event of any change in legislation affecting the operation of the Scheme; or
 - b. At any time on giving you not less than 3 months notice in writing
7. The first month's free childcare and free registration is only available to new parents transferring from another Childcare Provider to a Leapfrog Day Nursery and not to existing Leapfrog Day Nursery customers. It will not be available to any parent whose child has been attending a Leapfrog Day Nursery for the preceding 12 weeks.
8. We, Leapfrog Day Nurseries Limited, are the data controllers (for the purpose of the Data Protection Act 1998) of any personal information that we receive from you on behalf of yourself and your child/children. We will use this information for the purpose of running the Scheme.
